### DAVID ROGERS TO BECOME MANAGING PARTNER OF FOULSTON SIEFKIN LLP JUNE 1, 2023

The partners of law firm Foulston Siefkin LLP have elected David Rogers as the firm's managing partner, effective June 1. Rogers is a trial lawyer with 35 years' experience; he is based in Wichita as part of the firm's Wichita litigation practice group. He succeeds interim managing partner Kevin Arnel, who stepped in after previous managing partner Jason Lacey departed to join another former Foulston partner in long-time firm client IMA's legal department.

Rogers becomes only the firm's 12th managing partner since the firm's founding in 1919. While Rogers adds managing partner responsibilities, he will continue to advise clients in his litigation practice. Arnel, a member of the firm's five-member executive committee, remains an active transactional attorney with a large not-for-profit, tax-exempt, and business practice. He had served as Foulston's managing partner for eight years prior to Jason Lacey's tenure.

"Kevin has served the firm so well," Rogers said. "He and our executive committee have already set the firm on a steady and successful path. Like the managing partners before me, I intend to support our lawyers and staff by promoting the values we have followed for more than 100 years: delivering excellent counsel and representation for our clients and service to the community where we live and work."
