Eric L. Sexton serves as a government affairs consultant to Foulston Siefkin's Government Affairs & Public Policy practice group. Sexton's thorough understanding of legislative processes, funding, and the people involved combine to make him an effective and well-informed advocate for clients whose businesses or industries are affected by local, state, or federal regulations, administrative agencies, or elected officials.
